Tariff A Mooring/Unmooring/Shifting

- A1.** For mooring or unmooring a vessel at quays, docks or dolphins.
For mooring and unmooring in the locks
- A2.** For mooring or unmooring a vessel in the Braakman harbour or at the Scheldt jetty:
- A3.** For shifting a vessel at quays, docks or dolphins.
Total distance not to exceed the LOA of the vessel times 2.

- a.** If, due to circumstances, the mooring or unmooring demands a second motorboat for the service mentioned at A1 and A3, the relevant tariff will be increased by 50%.
- b.** If the services, A1, A2 and A3 start later than half an hour after the moment at which, according to the order, the services would have started, after the expiration of the half hour till the beginning of the services, 50% of the relevant tariff is due for every hour.
- c.** If the services A1,A2 and A3 are cancelled within an hour before the services according to the order would have started, 50% of the relevant tariff is due.
- d.** If the services A1, A2 and A3 are cancelled after the moment at which the services according to the order would have started, 100% of the relevant tariff is due.

General Remarks

- I.** By a holiday is understood Easter-Monday, Whit Monday, Christmas day, Boxing Day, New Year's Day, the Queen's Day, Ascension Day and the official national holidays.
- II.** A part of an hour will be calculated as a full hour.
- III.** For all the above services a surcharge of 25% is due on weekdays from 18.00 hrs. till 06.00 hrs.
- IV.** For all the above services a surcharge of 50% is due from Friday 18.00 hrs. till Monday 06.00 hrs and on holidays. Holidays to count from 18.00 hrs on the preceding day until 06.00 hrs of the day following the holiday.
- V.** The “ Montis Mooring & Boat service b.v.” shall not be responsible for loss of, damage to, or any liability arising out of the above services.
- VI.** “ Nederlandse Bootlieden Conditioes 2002” are applicable on all services
- VII.** Tariffs mentioned are calculated on the overall length of a vessel, as officially published in Lloyd's Register of Shipping.
